Essential Job Functions/Responsibilities:

- 1. Main communicator during the day fielding requests for setup/teardown and building questions/concerns
- 2. Assists with planning, prioritizing, and scheduling of work to be performed by custodians
- 3. Supervise the work load of night custodian
- 4. Maintains accurate equipment and maintenance records, including testing of equipment.
- 5. Reports maintenance requests to the building principal and/or director of Facilities and Grounds
- 6. Keeps buildings clean, in an orderly condition, and in good state of repair
- 7. Vacuums, sweeps, mops, and scrubs corridors, stairways and restrooms according to approved practices
- 8. Removes litter and recycling from rooms daily
- 9. Makes minor furniture and equipment repairs
- 10. Replaces burned out electric lamps in rooms and corridors
- 11. Removes snow from sidewalks and entrances
- 12. Assists in lawn and grounds maintenance
- 13. Assists principal and teachers with various details pertinent to the welfare of the school and the children
- 14. Must demonstrate professionalism and confidentiality at all times
- 15. Ability to create and sustain positive and effective interpersonal relationships in the workplace
- 16. Communicate a warm, caring and respectful atmosphere to visitors, staff and community members that focus on quality customer service.
- 17. Perform other duties as assigned.
- 18. Serves as a positive role model for students in how to conduct themselves as citizens and as responsible, intelligent human beings.

19. Will remain free of any alcohol or illegal substance in the workplace in compliance with Policy 3122 throughout his/her employment in the District.
