B. DPI Charter Benchmarks-Dr. Whitrock is going through the contract to ensure all



benchmarks are in the contract. Carie has asked Dr. Whitrock if she will be completing this document for Journey or if we are still responsible as we have done it in years past.

There is a new DPI benchmark that indicates: "Evidence that the charter governance board is a legally incorporated governing board independent of the authorizer. *This is evidence that the charter governance board is a nonstock corporation, for profit corporation, LLC, or partnership organized under the laws of the State of Wisconsin.*"

Dana Moracco sent Jonah an email regarding this benchmark to see if it applied to existing charters and received the following email from Jonah:

Cassi Benedict from the DPI (Cassandra.Benedict@dpi.wi.gov) is a good contact for learning more about the new requirement - which will apply for future charter renewals . She wrote, "The requirement for a charter school governing board to be a legal entity d party to the charter contract was included in 2015 WI Act 55, the 2015-17 state biennial budget bill, which was effective in July 2015. In August of 2015, the department provided all authorizers and charter school operators with a summary of the law changes. The summary noted the new provisions would apply to charters entered into, updated, or renewed after the effective date of the bill. We are requesting to have documentation of the separate legal entity when you submit the contract renewal to the DPI."

*After further conversation with Nick Pretasky at WRCCS, he confirmed that Journey Charter School is nonstock 501(c)3 and that includes the Governance Council so we are all set. He did indicate that older charter schools that never became 501(c)3, like Quest and Catalyst, would need to do so at this time.
