2. Act 55 and our current board composition

Catalyst's contract with the RASD is up for renewal next school year - April 2020.

A concerned citizen contacted a school board member to share that Catalyst is not in compliance with Act 55, which states that the Governance Board can not be comprised of more school district employees than non school district employees. The Governance Board currently has 4 RASD members (Carlie Cardinal, Kyle Sackett, Renee Schoff and Sarah Rieder) and only 2 non RASD members (Candie Baker, Brian Ernst). Catalyst's contact with RASD states that the board will be comprised of 7-9 members (2-3 parents, 2-3 community members, 1-2 teachers and 1 principle).

It has become difficult to find new board members the last few years. Candie will draft a letter that will be sent out through IC to parents of current Catalyst, Quest and Murray Park students stating that Catalyst is looking for additional parents and community members for the board.

Next year the board will look into changing the contract to only 5-7 board members or a board of no more than 7, when it goes for renewal in April 2020.
