  - 4.1. Curriculum
    - 4.1.1. Data Reporting Methods. CQI district. Schools use Continuous Quality Improvement, It constantly changes and is updated as classes go through the semester. It has been a huge motivator for individual kids to keep track of their progress and they know right where they are. Data walls in each classroom shows goals and benchmarks towards achievement. Kids are becoming data savvy. Renee shared an example of the data wall. Shows great improvement. Curricula was piloted 4-5 years ago and began to roll it out the following year. Deb W. mentioned that all parents should see this data and they would be impressed. The schools share the composite data with the school board, If we were allowed to have parents in the classroom the parents would be able to see the data boards.
    - 4.1.2. Implementation of PBL during the Pandemic. Doing the best they can and collaboration, innovation and technology are being incorporated into each grade and project. Virtual project showcase is expected to come in March and May.
    - 4.1.3. Inclusion of Virtual students. Virtual students were included in both the projects and the small group work. Their scores were included in GQI data wall, too.

For example, Schools are expected to receive ESSER funds. Will help to keep class sizes small. Expect to hire and retain full + part time reading interventionists: Will put caps on open enrollment. 35 new kids came to school this year. Want summer school fully in-person. That info will come out before spring break. Next year will encourage any virtual students to enroll in Odyssey.
