The cycle that we were on was ending on 4 of 5 years, had to reapply for 5th year of funding. Reached out to DPI to go forward, asked if authorizer had taken any action which hadn't gone through, so they applied and received the 154,00. A budget was submitted, during that process they were notified that we may not have been permitted to do so in the first place Requested another DPI meeting to figure what is happening- they are looking for answers clarified.
