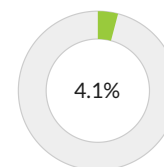

Subject Area Scores



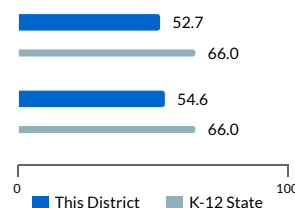

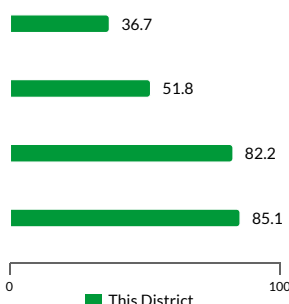

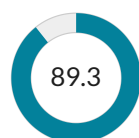

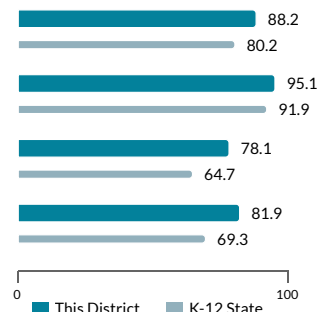

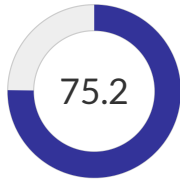

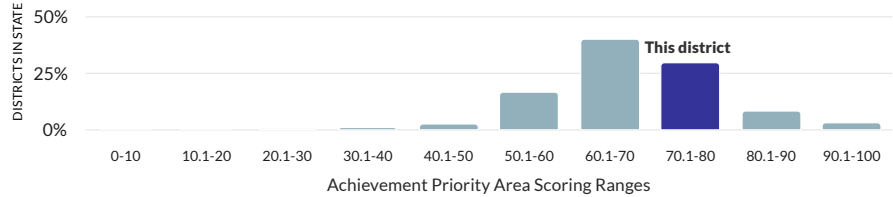

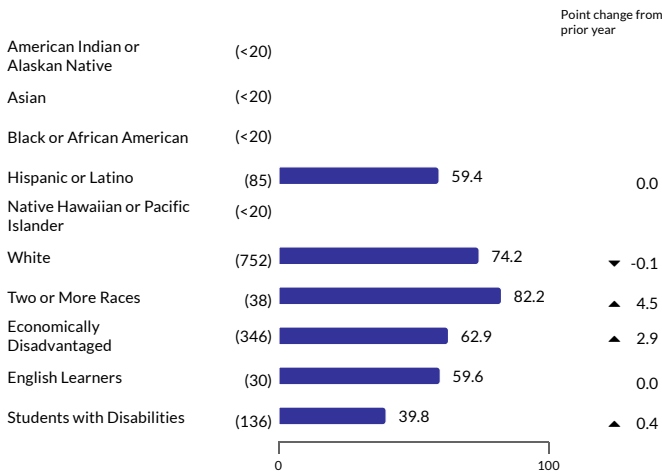

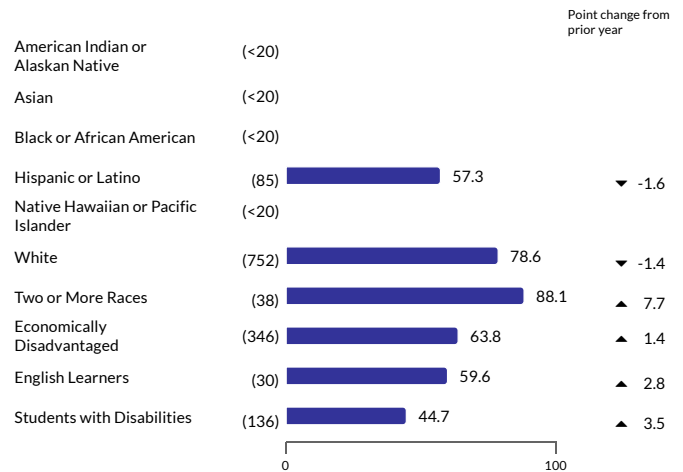

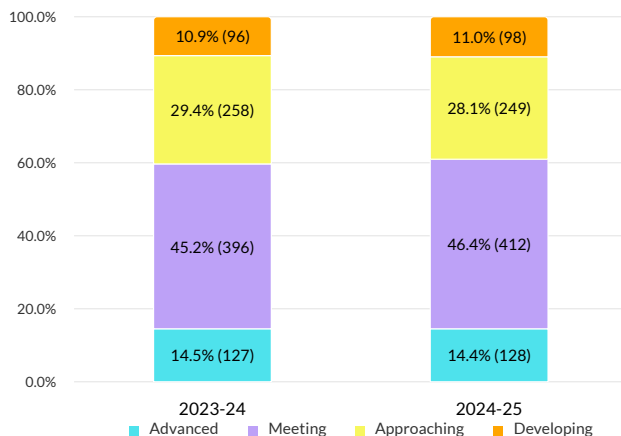

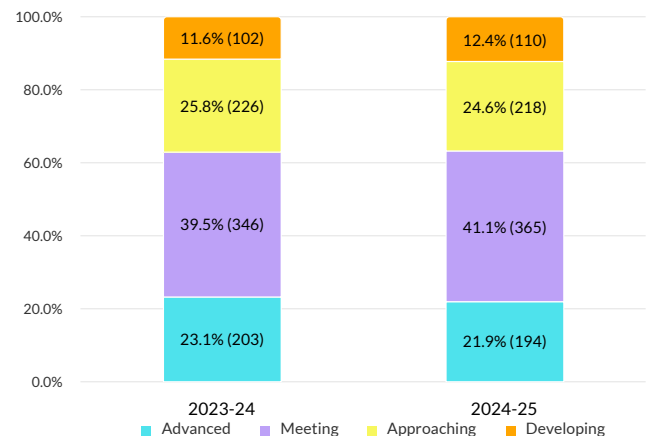
Performance Levels by Year

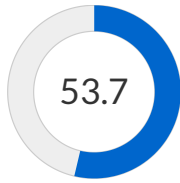

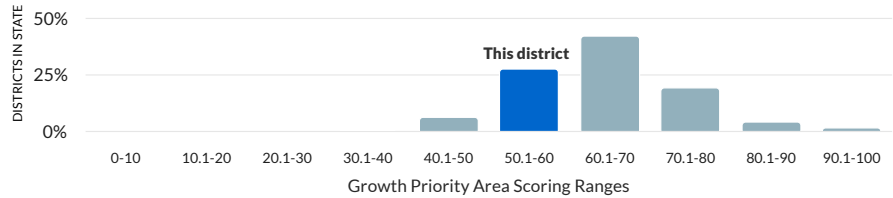
This priority area measures year-to-year student progress on statewide tests. It uses a value-added model that seeks to control for circumstances beyond the influence of educators. A high value-added score means that on average students in the district are progressing more quickly than other, similar students. 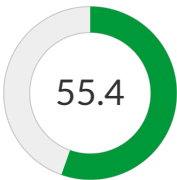

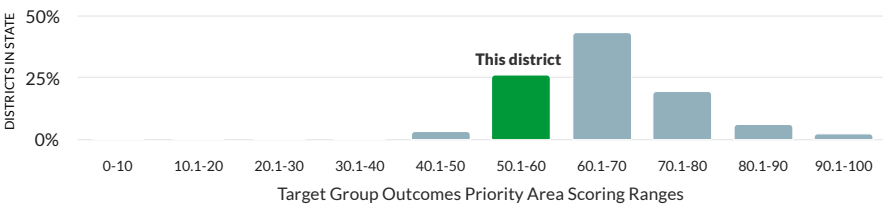
TARGET GROUP OUTCOMES

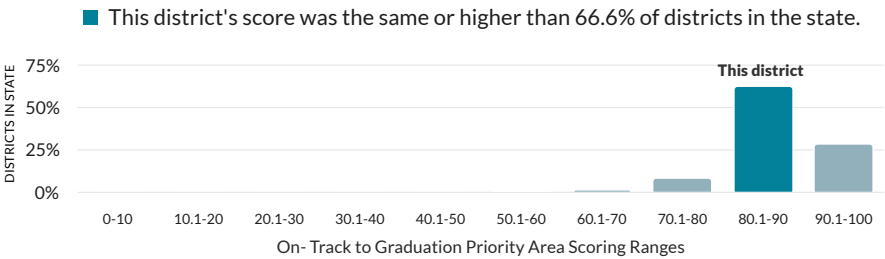
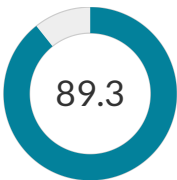

CERTAIN STATE & LOCAL LAW VIOLATIONS, 2024-25

Schools and school districts must report a law violation to DPI only if all three of the following criteria are met: 1. A charge was filed or a citation was issued as a result of the incident.

Violations must also fall into one of the following eight categories: 1. Homicide; 2. Sexual assault; 3. Burglary, robbery, or theft; 4. Certain types of battery; 5. Arson; 6. Use or possession of alcohol, a controlled substance, or a controlled substance analog; 7. Unlawful possession of a firearm on school grounds; or 8. A violation of a municipal ordinance related to disorderly conduct.

There are multiple limitations affecting the quality and completeness of this data.
