

English Language Arts Score: 78.4






Performance Levels by Year




GROWTH




TARGET GROUP OUTCOMES



Use or possession of alcohol, a controlled substance, or a controlled substance analog; 7. Unlawful possession of a firearm on school grounds; or 8. A violation of a municipal ordinance related to disorderly conduct.
